WHEREAS, as provided in Article III of the Declaration, ".....Declarant, its successors and assigns, shall have the right, without the consent of the Association, to bring within the plan of development and operation of this Declaration, additional properties in future stages of the development......"; and

WHEREAS, in accordance with said Article III, Declarant now intends to subject the Property to the Declaration;

NOW, THEREFORE, for the purpose of enhancing and protecting the value, attractiveness and desirability of the Property, the Declarant hereby declares that the Property and each part thereof shall be held, sold, devised and conveyed subject to the Declaration which shall constitute covenants running with the land and shall be binding on all parties having any right, title, or interest in said Property or any part thereof, their heirs, executors, administrators, successors and assigns and shall inure to the benefit of each Owner (as defined in the Declaration) thereof.
