THIS Consent to the Application of the South Carolina Uniform Act Regulating Traffic to the Private Roads within **FERNLAKES**, **HOA** this ("Consent") is made on Recordation in the public records of Beaufort County, South Carolina.

WHEREAS, the Board of Directors of **FERNLAKES**, **HOA** at a meeting called and held on **June 28**, **2018** at 181 Bluffton Road, Suite C104, Bluffton, SC 29910, did unanimously resolve and agree to subject the private roads within **FERNLAKES**, **HOA** to the South Carolina Uniform Act Regulating Traffic;

NOW, THEREFORE, in accordance with Section 56-5-6310 and Section 56-5-6340 of the Code of Laws of South Carolina (1976), as amended, **FERNLAKES**, **HOA** makes the following statements:

- 1. FERNLAKES, HOA is the owner of the private roads located within FERNLAKES, HOA known as FERNLAKES, HOA as shown on the Master Plan, for FERNLAKES, HOA. Said Private roads are Fernlakes Drive, Cinnamon Fern, Bracken Fern, Royal Fern, Holly Fern and Brittle Fern.
- 2. THAT **FERNLAKES**, **HOA** does hereby consent to the applications of the provisions of Chapters 1,3,57, and 9 of Title 56 of the Code of Laws of South Carolina (1976), as amended, Uniform Act Regulating Traffic on highways of South Carolina, to all private roads located within the property commonly known as **FERNLAKES**, **HOA** as shown on the master plan.
- 3. That this affidavit is expressly made pursuant to Section 56-5-6310 of the Code of Laws of South Carolina (1976), as amended and shall not be construed as a dedication of such roadway to the public nor shall it constitute permission by **FERNLAKES**, **HOA** for the public use of such roads;
- 4. That this consent shall be effective until **FERNLAKES, HOA**, its successors or assigns, terminate such consent by filing a Notice of Termination simultaneously with the Clerk of Court for Beaufort County, South Carolina.

- 5. **FERNLAKES**, **HOA** has established speed limits and placed traffic control signs on said roads as shown in Exhibit A attached. Said plan has been submitted to P.J. Tanner, Sheriff of Beaufort County, South Carolina and Sheriff Tanner has approved of such speed limits and traffic control signs.
- 6. This Consent is executed by **FERNLAKES**, **HOA** by submitting this Consent in accordance with Section 56-5-6340(a) of the Code of Laws of South Carolina (1976), as amended.


This approval shall remain in effect until otherwise terminated by the filing of a notice of termination as specified by South Carolina State statute 56-5-6320 and as amended.
