Courtside service yard name plaques can be installed by an owner, *if they wish and agree to follow the below listed specs and conditions upon installation.*

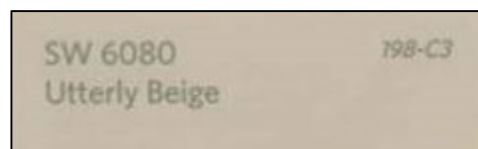
