Said Original Covenant, First Amendment, First Supplement, Second Supplement, Third Supplement, Fourth Supplement, Fifth Supplement, Sixth Supplement, Seventh Supplement, Eighth Supplement, Ninth Supplement, Tenth Supplement, Eleventh Supplement, Corrective Seventh Supplement, Twelfth Supplement, Thirteenth Supplement, Fourteenth Supplement, Fifteenth Supplement, Sixteenth Supplement, Seventeenth Supplement, Eighteenth Supplement, Nineteenth Supplement, and Assignment, and any future amendments or supplements thereto are collectively referred to herein as the "Covenant"; and

WHEREAS, pursuant to the terms of Section 7.3(a) of the Covenant, Section 4.3 of the By-Laws of Bluffton Park Community Council, Inc., as the same are recorded in the Covenant (the "By-Laws"), the Declarant is currently authorized to unilaterally amend the Covenant at any time and from time to time; and

WHEREAS, the Declarant now desires to amend the Covenant to remove a portion of the Property encumbered by the Covenant and to amend and restate Exhibit "A" of the Covenant, all as more particularly stated below (the "Amendment"); and

WHEREAS, subsequent to such Amendment, the Declarant desires to assign all of its rights, powers, and interest as Declarant under the Covenant to that certain entity known as the Bluffton Park Community Association, Inc., a South Carolina non-profit corporation (the "Assignment").

NOW, THEREFORE, for and in consideration of the premises herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Declarant, hereby declares and agrees that the real property previously submitted to the Declaration, is and shall be held, transferred, sold and conveyed and/or otherwise occupied subject to the covenants, restrictions, easements, charges and liens hereinafter set forth and as already set forth in the Declaration, as hereby amended and as may be further amended and supplemented, as follows:

- Recitals and Definitions. The above recitals, by reference hereto, are incorporated herein as fully as if fully restated verbatim herein and are a material part of this Second Amendment and Assignment. Any capitalized term used but not defined herein shall have the meaning ascribed to it in the Declaration.
