2021 HOA Fees & Road Reserve Assessment

The annual meeting packet will be coming to you in the mail very soon with the 2021 budget detailing necessary changes. The 2021 HOA fees will be increased to \$286.65 per quarter, still due the 1st of January, April, July, and October and late by the last day of that respective month. Be sure to sign up for auto-pay by logging back into www.imchhi.com payment portal. The third payment for the Road Reserve assessment will be mailed out to all homeowners in March 2021 in the amount of \$200. The assessment will continue to be billed annually through 2023 to fund the repairs of the roadways throughout Fernlakes.

Storage Yard

The storage yard is leased out at full capacity so far this year. Please remember there is no video surveillance in the area and leases are Hold Harmless which means the HOA is not responsible for your personal items being stored. Owners should insure their property.

Amenity Center Upgrades

If you haven't visited our amenity center this summer you should take a stroll and see the recent upgrades. The pool house received a new metal roof, new shower pergola, new siding and exterior paint. In addition, the original playground structure and swings had outlived their useful life. The Board approved to replace the old wooden structure with a new commercial grade play structure accompanied by a 2-bay swing set housing 4 swings, 2 coated benches, and rubber mulch groundcover within the play area. Additional estimates are being obtained to install wood mulch in the exposed ground areas.

The neighborhood children are having a blast on the new playground and moms, I'm sure, are appreciating the bench seating.

Pool Closing November 2nd

Be on the lookout for even more upgrades coming this Fall to the amenity center which will include new aluminum fencing. The Board has approved installing new 6' aluminum black spindle fencing around the playground and pool area which will be expanded to include an additional grassed area for more room when sun bathing. Also, regrading and gravel costs are being reviewed to upgrade the storage area.

All of these wonderful upgrades were able to be completed and paid for using the association's reserve fund.
